
Dear colleagues!

More than half of the purchased books were published within the last six years. The most popular subjects were economics, history, political science and law. Take a look at the top three of the most popular books below!



The Habsburg Empire: A New History

P. M. Judson *electronic book*


In a panoramic and pioneering reappraisal, Pieter Judson shows why the Habsburg Empire mattered so much, for so long, to millions of Central Europeans. Across divides of language, religion, region, and history, ordinary women and men felt a common attachment to their empire, while bureaucrats, soldiers, politicians, and academics devised inventive solutions to the challenges of governing Europe s second largest state. In the decades before and after its dissolution, some observers belittled the Habsburg Empire as a dysfunctional patchwork of hostile ethnic groups and an anachronistic imperial relic. Judson examines their motives and explains just how wrong these rearguard critics were.



The Book of the Twelve: Hosea-Jonah

Over the last thirty years, scholars have begun to explore the implications of an ancient Jewish and Christian tradition that referred to the "Minor Prophets" as "the Twelve," "the Twelve Prophets," or the "Book of the Twelve." Scholarly work on the Book of the Twelve in the last quarter century has focused on two issues: (1) examining how the Book of the Twelve came to be recorded on a single scroll and (2) isolating unifying elements that transcend the individual writings and take on new significance when the Book of the Twelve becomes a single collection. Nogalski's comprehensive commentary offers an overview of the ancient traditions concerning the Book of the Twelve that lays the foundation for understanding these recent developments. Written by accomplished scholars with all students of Scripture in mind, this innovative new commentary series is designed to make quality Bible study more accessible.



The Gravity Model in International Trade: Advances and Applications

P. A. G. van Bergeijk, S. Brakman *electronic book*

How do borders affect trade? Are cultural and institutional differences important for trade? Is environmental policy relevant to trade? How does one's income or wage relate to the fact that trade partners are nearby or far away? These are just some of the important questions that can be answered using the gravity model of international trade. This model predicts and explains bilateral trade flows in terms of the economic size and distance between trading partners (e.g. states, regions, countries, trading blocs). In recent years, there has been a surge of interest in this model and it is now one of the most widely applied tools in applied international economics. This book traces the history of the gravity model and takes stock of recent methodological and theoretical advances, including new approximations for multilateral trade resistance, insightful analyses of the measurement of economic distance and analyses of foreign direct investment.



The Ever-Changing Past: Why All History is Revisionist History J. M. Banner Jr. 2021 printed book

History is not, and has never been, inert, certain, merely factual, and beyond reinterpretation. Taking readers from Thucydides to the origin of the French Revolution to the Civil War and beyond. James M. Banner, Jr. explores what historians do and why they do it. Banner shows why historical knowledge is unlikely ever to be unchanging, why history as a branch of knowledge is always a search for meaning and a constant source of argument, and why history is so essential to individuals' awareness of their location in the world and to every group and nation's sense of identity and destiny. He explains why all historians are revisionists while they seek to more fully understand the past, and how they always bring their distinct minds, dispositions, perspectives, and purposes to bear on the subjects they study.

Монография посвящена ключевым вопросам теории исламского права как юридического феномена. Автор формулирует понятие исламского права в его соотношении с шариатом и фикхом, определяет его место в современных правовых системах мусульманских стран. The Council of Ephesus of 431: Documents and Proceedings

R. Price, T. Graumann 2020 printed book

The First Council of Ephesus (431) was the climax of the so-called Nestorian Controversy. Convoked by the emperor Theodosius II to restore peace to the Church, it immediately divided into two rival councils, both meeting at Ephesus. Attempts by the emperor's representatives to get the bishops on both sides to meet together had no success, and after four months the council was dissolved without having ever properly met. But a number of decrees by the larger of the two rival councils, in particular the condemnation of Nestorius of Constantinople, were subsequently accepted as the valid decrees of the 'ecumenical council of Ephesus'. The documentation, consisting of conciliar proceedings, letters and other documents, provides information not only about events in Ephesus itself, but also about lobbying and public demonstrations in Constantinople.



Across the South of Asia: A Volume in Honor of Professor Robert L. Brown

This collection of essays invites readers to take a broad view of South Asian art and culture by providing a wide geographic and chronological scope. The articles are united only by their focus on art historical and archaeological concerns and their concentration on South Asia ranging from Afghanistan to the island kingdoms of Indonesia. Each essay on its own constitutes a solid, well-grounded academic study, but taken collectively they provide a wide and inclusive view of issues of art and material culture that span the region and invite comparison. By taking this approach, this volume is a tribute to Prof. Robert L. Brown whose lifetime of teaching has always emphasized connections as well as differences. Over his professional career, he has trained a large cohort of students (many of whom are contributors to this volume) whose expertise truly does reach across the south of Asia.


Апат Сага. Кельтская мудрость Д. О'Донохью 2021 печатная книга


